## **Bloomington Archery Club**

## Club Rules and Regulations

- 1). All club members are invited and welcome to all meetings of the board of directors to provide input as to how the club is operated and activities provided; and propose any changes to the club.
- 2). The entrance gate should remain closed and locked at all times when there are no members on the property. The lock will be changed annually with all current members being provided a new key.
- 3). The club buildings are to remain locked at all times unless being used for an official club activity. Keys to buildings are restricted to board members only.
- 4). All club members are expected to help maintain the property, be respectful of use by other members, use safe practices in all activities on the property, and report unsafe conditions or situations, or items needing attention, to a board member. Failure to act properly and respectfully will be grounds for suspension or revocation of membership by the Board of Directors.
- 5). All children on the premises must be accompanied by a parent or responsible adult, who is responsible for their actions and safety.
- 6) .The club will strive to provide all pertinent information about the club, rules, and activities on the club's website at Bloomingtonarchery.com. Please see rules for our archery shoots posted in the clubhouse (as well as online at www.bloomingtonarchery.com).
- 7). All guest archers are required to have a signed liability waiver on file with the club.
- 8). All archery shoots are subject to cancellation at any time (even during a shoot) as conditions or weather dictate, for the safety of all involved
- 9). All archery shoots will be conducted by rules and instructions posted at the club house. Rules infractions may result in disqualification. Unsportsmanlike conduct will not be tolerated and may result in disqualification or removal from the grounds.
- 10). All shooting of bows is limited to the warm up area, practice range, and sanctioned 3D range.

- 11). Please help keep our grounds clean by not littering. Please keep your club clean and safe by picking up trash, fallen limbs on trails, and any other actions to improve our grounds.
- 12). Individually owned ATV's, four wheelers, dirt bikes, and related vehicle types are not allowed on the club property.
- 13). Well behaved animals are welcome; but must be leashed at all times. You are responsible for and expected to clean up after them. No horses.
- 14). Smoking and vaping are not allowed in the clubhouse.
- 15). Use of, or being under the influence of, illegal drugs will not be tolerated on the club property. Anyone caught, or suspected of, violation of this policy will be asked to leave the property. If anyone refuses to leave, the Monroe County Sherriff department will be contacted to resolve the issue.
- 16). Public intoxication, and possession, or consumption, of alcoholic beverages by persons under the age of 21, are illegal and will not be tolerated. Anyone caught or suspected of, violation of this policy will be asked to leave the property. If anyone refuses to leave, the Monroe County Sherriff department will be contacted to resolve the issue.
- 17). Consumption of alcoholic beverages and/or use of controlled substances will not be tolerated prior to or during any shooting activities. Anyone suspected of violating this rule will be asked to leave the shooting area, disqualified from the shoot, and subject to disciplinary actions by to board, up to and including revocation of membership.
